I hereby confirm that my date of birth and all other data provided by me are correct. I assure that I will not pass on my starting authorization to any other person. The organizer accepts no liability for the loss of clothing and valuables. The organizer is not liable for the accuracy of the data from the jury's assessment. The organizer is entitled to make changes to the event at any time. Such changes do not justify any claims for damages on the part of the participants. With my signature, I declare that I am taking part in the event at my own responsibility and risk.

DISCLAIMER

Furthermore, I declare that in the event of damage, I have no claim whatsoever against the organizer, the site owner, the authorities associated with the event or other participants and that I am adequately insured against accidents and liability claims. The exclusion of liability applies to claims on any legal grounds, in particular to claims for damages arising from contractual as well as non-contractual liability and also to claims in unauthorized actions.
